CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, Immanuel Arasar B.Ed. College of Education, Edavilagam, Nattalam (Village & Post), Vilavancode Taluk, Kanyakumari District-629195, Tamilnadu vide SRC (NCTE) order no. F SRO/NCTE/B.Ed./2007-2008/3803 dated 06.06.2007 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, the recognition was granted to the institution namely, Immanuel Arasar B.Ed. College of Education, Edavilagam, Nattalam (Village & Post), Vilavancode Taluk, Kanyakumari District-629195, Tamilnadu vide SRC (NCTE) order no F.SRO/NCTE/B.Ed.-A.I./2006-2007/48 dated 03.04.2008 for conducting Secondary B.Ed.-A.I. course of one-year duration with an annual intake of 100 students.
- AND WHEREAS, the SRC issued a corrigendum order no. F.SRO/NCTE/B.Ed/2007-2008/2262 to the institution on 17.06.2008 for conducting B.Ed-Al course of one year duration with an annual intake of 200(Two hundred) students which includes the existing intake of 100(Hundred) students and an additional intake of 100(Hundred) students.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 05.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 08.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16. A revised provisional recognition order was issued to the institution on 23.03.2015 for conducting B.Ed.-A.I. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 has considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 01.10.2020. The institution vide letter dated 17.10.2020 submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 395th meeting held on 25th 26th February 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 22.03.2021. The institution vide letter dated 09.03.2021 submitted reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 397" meeting held on 25th 26th March, 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 08.04.2021. The institution vide letter dated 13.04.2021 submitted reply to the Final Show Cause Notice

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Immanuel Arasar B.Ed. College of Education, Survey No. 926/39, 43, 44, Edavilagam, Nattalam (Village & Post), Vilavancode Taluk, Marthandam, Kanyakumari District-629195, Tamilnadu for B.Ed. programme for 4 basic units of 50 students each".

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Institution Immanuel Arasar B.Ed. College of Education, Survey No. 926/39, 43, 44, Edavilagam, Nattalam (Village & Post), Vilavancode Taluk, Marthandam, Kanyakumari District-629195, Tamilnadu for Continuation of recognition for B.Ed. programme for two year duration (4 basic units) of 50 students each subject to fulfillment of the following conditions:
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations. 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
